To the Kane county Board voting on Petition # 4666 in regard to solar field proposed to be built on much valued and needed farm land only 150 ft from outside wall of houses, the 150 feet including their property of the homeowners of the houses.

Can we not convince the solar companies and our town leaders to build the solar fields away from existing housing and proposed future housing projects of our adjacent communities and work toward goals together with property owners alike.

Secondly, We passed by several solar fields between Bloomington and Saint Charles, we saw arborvitae's dead on the circumference bordering the solar fields and in other states some fire departments view this plant as a fire risk.
